Funding Appeal

Organization: EMS

SSR28AL007-PASSED

Amount: \$1,000.00

EMS was appealing a previous decision to fund them \$13,500 for the current year. They hope to receive addition funds in order to help them fund mainly fuel and equipment costs. The Allocations Committee believes that this club does require additional funding, and therefore recommends an additional \$1,000. They also think that should EMS need more funding for specific equipment or necessities, such as Epi-Pens at \$800 per unit, to file an additional funding request.

Funding Appeal**SSR28AL008-PASSED**

Organization: Indian Student Association (ISA)

Amount: \$400.00

ISA was appealing a previous decision to fund them \$825 for the current year. They believe they need more funds in order to help them pay for various events around campus, especially Holi and Namaste Lehigh. The Allocations Committee recognizes the clubs strive for providing culturally diverse events to be enjoyed by the entire campus and believes that they do deserve some additional funding to help cover the cost of events. Because of this, the Allocations Committee recommends \$400.

Funding Appeal**SSR28AL009-PASSED**

Organization: World Youth Values Society

Amount: \$0.00

WYVS was appealing a previous decision to fund them \$150. They are requesting money to help fund various events, including EdUnited and WYVS's annual meeting. While The Allocations Committee believes that they have some great causes, they didn't modify their budget for their appeal from the previous decision and didn't cite any specific changes, while at the same time missing critical info to allow certain funding, such as the location or specific price of flight for their annual meeting. Because of this, the Allocations Committee recommends no additional funding.

Funding Appeal**SSR28AL0010-PASSED**

Organization: Asian Cultural Society

Amount: \$0.00

The Asian Cultural Society was appealing a previous decision to fund them \$2,220 for the year. The reasoning behind their request for additional funding was to help cover food and other costs for closed events only for their due-paying members. Due to the exclusivity of their events and the fact that they have an already large amount of money in their club funds, the Allocations Committee recommends they seek other sources of revenue as well as income from its members.
